## The 2+2 on Innovation in Logistics

### Delegate Information

We are pleased to assure that you can rely on a sophisticated hygiene and safety concept that we constantly adapt to current requirements of the state of California and City of San Francisco.

**In order to attend the event all delegates, exhibitors and speakers will be required to provide proof of a negative Covid test or a COVID-19 vaccination at registration desk before receiving their conference badge and entering the event.**

The city of San Francisco is requiring a **negative test** be a PCR-lab test within two days of entrance, or within one day of entrance with a verified antigen test. Attendees must provide:

- A printed document from the test provider or laboratory
- or an electronic test result displayed on a phone or other device from the test provider or laboratory.

The information should include the person's name, type of test performed, and negative test result.

To ensure you are equipped to verify your attendee's **proof of vaccination**, City requirements are outlined below:

Valid forms of vaccination proof include Valid Photo ID and:

- Original, copy or picture of your CDC vaccination card
- or documentation from a healthcare provider
- or personal digital COVID-19 vaccine card
- Attendees need to have their vaccination series completed two weeks prior to the event.

Wearing face mask is optional at the event. You may choose to do so for the protection of all attendees.

#### **Where and when do I get my badge and show my proof of vaccination?**

You receive your badge at the registration desk located at the entrance to Grand Foyer. Proof of vaccination, along with photo ID, will be checked there. You may already stop by upon arrival on Monday, 21 March to receive your badge. A member of our team will be at the registration from 11 am onwards.

#### How do I show proof of my vaccination status?

For vaccine received in the United States we recommend to set up a [\*\*CLEAR Health Pass\*\*](#) before arriving.

For vaccine received outside of the USA, please bring a physical, digital or QR code proof of full vaccination along with a photo ID.

#### If you need a PCR test for travelling after the event, please find below options for PCR testing.
